25 At 6:23 p.m., due to the excused absence of the President of the Council, the Town Clerk called the
26 meeting to order and entertained a motion from Mr. Lesher seconded by Mrs. Cook and carried
27 unanimously to nominate Mr. Wendowski as acting President of the Council.

31 Chief Spencer introduced 1st Sgt. Rhonda Thomas.

33 1st Sgt. Thomas discussed the Data Driven Approaches to Crime and Traffic Safety (DDACTS) program
34 which was introduced in 2008. She stated that she has worked with Capt. Hall from Baltimore County.

36 DDACTS is a law enforcement operational model which integrates located-based crime and traffic crash
37 data to establish effective and efficient methods for deploying law enforcement and other resources.

39 1st Sgt. Thomas discussed objectives and compliance efforts.

41 Chief Spencer stated that this program is predicated on statistical information but has already been
42 implemented by Easton Police Department.

44 Mr. Karge asked Chief Spencer to discuss the ability to enforce a noise complaint.

46 Chief Spencer discussed personnel, the 20th Easton Police Department Toy Drive, and the upcoming
47 Annual Awards Ceremony.

49 Chief Spencer stated he will be present at the March 7 council meeting to present Easton Police
50 Department's yearly report.

52 Chief Spencer stated that the department will be changing the department's fleet over to new gold
53 letters and a waving flag.

55 Discussion occurred regarding Immigration and Customs Enforcement (ICE).
