Regular Park Advisory Board meeting brought to order by the chairperson, Mr. Mike Weise. Minutes of previous meeting read and approved.

Mrs. Gould updated Board members on park:

North Easton Sports Complex: Getting ready for baseball and lacrosse. Applications for field use have been received and permits mailed to the users. There will be an outside contractor running the concession stand.

Moton Park: Mrs. Gould and members of the Board discussed placing the fence parallel to the by-pass at Moton Park. The fence will need to be out of the State's right of way. pass at Moton Park. Public Works will mount them at the entrances of the tennis area. Easton Rotary requested placing flags in the park again this year. Members agreed this is a good effort. Restrooms will open soon as the weather allows.

Mrs. Gould shared with Board members the request for reserving RTC Park for an "Ole time" baseball game. Reservations are not being accepted for RTC Park. Park Board thought maybe the group would like to use the baseball areas at Idlewild Park. The group informed Mrs. Gould that the men would possibly hit the ball in the play area. The group will try other places to find a spot. If they cannot find anything they will contact Mrs. Gould again.
