Regular Park Board meeting brought to order by Mr. Michael Weise. Upon motion by Mr. Otis Sampson, seconded by Mr. Michael Brophy and carried unanimously, minutes of the May 23, 2016 meeting were approved as written.

Mr. Robbie Gill with the YMCA of the Chesapeake spoke to members of the Park Board concerning field usage at RTC Park for the YMCA soccer program. The time line would be from August to late October. He stated, the YMCA staff will bring in temporary goals when they come in and take the goals out when they leave daily. There will be no lining of the fields. Just need a space to use. After discussion Park Board members voted to allow Mr. Gill to use space in the RTC Park for the soccer program. He will coordinate with Mrs. Gould date and times so she will be aware they are using the park, but no permits will not be issued.

Mr. David Valliant spoke with members of the Park Board requesting information on types of material he should use on property he owns near Pippin Farms. He would like to place nature walking trails and ideas of amenities to place on the area. After discussion to see what Mr. Valliant needed from the Park Board, the Park Board directed him to Pickering Creek.
