PRESS RELEASE

- **Arrest Warrant Service:** On August 29, 2015, Easton Police served an arrest warrant on 25 year old Evony Marquis Stanley of Federalsburg, MD in reference to a theft. According to the charging documents, Stanley stole merchandise from Walmart of Easton, then conducted an in store exchange of the stolen items to receive gift cards. The Criminal summons charged Stanley with Theft under \$100.00, Theft under \$1000.00, Conspiracy to commit theft under \$100.00 and Conspiracy to commit theft under \$1000.00. Stanley was taken before a District court commissioner and released on her personal recognizance.
- **Theft under \$1000.00:** On August 29, 2015 at approx. 10:32 PM, Easton police responded to Walgreens in reference to a theft. Upon arrival, store employees advised that a female subject was observed removing make-up and then placing into her back pack. A search of the backpack revealed make-up items from Walgreens still in the original packaging. The suspect, identified as 43 year old Celeste Payne Sanborn of Easton, MD was placed under arrest and charged with 1 count of theft under \$1000.00. Sanborn was taken before a District court commissioner where she was released on her personal recognizance.
- **Criminal Summons Service:** On August 29, 2015, Easton Police served a Criminal Summons on 26 year old Ashley Nicole Booze of Church Creek, MD in reference to CDS Possession. According to the charging documents, Officers located suspected heroin, paraphernalia utilized to cook heroin and a syringe in a crown royal bag found in Booze's purse. The criminal summons charge Booze with CDS possession: Not Marihuana, CDS: Possession of paraphernalia and CDS administering equipment. Booze was released upon her signature of the charging documents.
- **Criminal Summons Service:** On August 28, 2015, Easton Police served a Criminal on 22 year old Sabre Monique Boulden of Easton, MD. According to the charging documents, this incident centered around a McDonald's employee entering the store after hours and removing cash. Boulden allegedly entered the store after store hours and removed money from a safe and deposit bag. This incident occurred at the McDonalds on the Easton Bypass. Boulden was released upon her signature of the charging documents.

- **Criminal Summons Service:** On August 28, 2015, Easton Police served a Criminal Summons on 18 year old Brian Marrero of Hurlock MD. According to the charging documents, Marrero stole merchandise from Walmart of Easton on February 24, 2015. The merchandise value was under \$100.00. Marrero was released upon his signature of the charging documents.
- **Criminal Summons Service:** On August 30, 2015, Easton Police served a Criminal summons on 18 year old Jaurice Kashawn Henry of Easton, MD. According to the charging documents, a large fight ensued in the area of Sidetrack salon on August 08, 2015 at which point, Henry allegedly assaulted different individuals. Henry is charged with 2 counts of assault 2nd degree. Henry was released upon his signature of the charging documents.
- **Possession of CDS and Driving Suspended / Revoked**
On August 29, 2015 at approx. 12:37 PM, Easton Police conducted a traffic stop in the area of Rt. 50 and Dutchmans Ln. The initial traffic stop was for the vehicle having suspended registration with a MD tag pick-up order. Initial contact with the driver of the vehicle, 27 year old Lindsay Marie Miller of Ridgely, MD provided information that her Driver's License was revoked and suspended. During the traffic stop, officers became suspicious of Miller's action at which time an Easton Police K-9 unit arrived on scene to conduct a K-9 scan of the vehicle. A subsequent search of the vehicle located several prescription pills that did not belong to Miller as well as items of drug paraphernalia. Miller was charged with CDS possession: Not Marihuana, CDS: Possession of Paraphernalia, Driving without a license, Driving on a suspended license, driving on a revoked license, driving with suspended registration and Driving an uninsured Vehicle. Miller was taken before a District court commissioner where she was released on her personal recognizance.
